KR started leading PHSE when the school subscribed to Jigsaw, so this is the 2<sup>nd</sup> year. Scheme works well and it's a whole school scheme. In 21/22 16% below, 83% ARE and 2% above. For 22/23 6% below, 93% ARE. Still early in the year to see above as still pushing ARE. Putting things in place for this and how we push these children.

Staff really like the Get Set PE scheme. It has clear objectives and progression and is taught in every class in school.




Just introduced a new online assessment tool which will be completed termly. Quick tool to use for staff and gives more thorough data.
